LETTER OF INTENT PRIOR TO GRANT OF RECOGNITION/PERMISSION

Subject: - Letter of intent prior to grant of recognition/permission under Clause 7(13) NCTE (Recognition Norms and Procedure) Regulations, 2014.

The NRC in its 273rd meeting (Part -2) held from 26th to 27th July, 2017 on the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and video-graph observed that the following institution has adequate financial resources, accommodation, library and laboratory as prescribed in the norms and standards and that it fulfils all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course and decided to issue Letter of Intent under clause 7(13) of the NCTE Regulations, 2014:-

- As per provision of clause 7(13) of the NCTE Regulations, 2014, the process of appointment of qualified staff as per policy of State Government or University Grant Commission or University may be initiated by the institution and affiliating body will provide all assistance to the institution to ensure that the staff or faculty is appointed as per National Council for Teacher Education norms within two months. The institution shall submit the list of faculty, as approved by the affiliating body, to the Regional Committee.
- In this regard as per decision taken by NRC in its 199th meeting, it is clarified that the above implies that where there exists a provision of nomination of expert/experts for the Selection Committee by the affiliating university, the same be adhered to. In the absence of such a provision in the Act/Statutes of the affiliating university, the institution shall select faculty members by employing a transparent, objective and judicious process and shall get the list of selected teachers approved by the effiliating university. This approved list along with details of educational qualifications and teaching experience, shall be submitted by the institution to the Regional Committee.
- As per Regulations, 2014 an institution can be given Maximum Two units for D.El.Ed. & B.Ed. programme.
- In view of above, before grant of formal recognition under Regulation 7(16) of the NCTE Regulations, 2014 is considered, the following documents are required to be submitted by the institution: -
- The institution shall submit particulars of the staff duly approved by the University'affiliating body as per prescribed format available on the NRC, NCTE website.
- Advertisement given for recruitment of faculty and staff. b.
- An affidavit on Rs. 100/-stamp paper to the effect that the institution has selected staff as per NCTE/State/University norms (Format Enclosed).
- Educational & professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal /HOD. The institution is required to appoint the faculty as per the provisions of the NCTE (Recognition Norms & Procedure) (Amendment) Regulations, 2017 dated 29.5.2017 notified on 09.6.2017 which inter-alia provides that the NET/Ph.D. (as per UGC (Minimum Standard and Procedure for award of Ph.D. Degree) Regulations, 2009) is now an essential qualification for the post of Lecturer/ Assistant Professor for B.Ed., B.El.Ed. and B.A.B.Ed./B.Sc.B.Ed. programmes.

e. Downloaded copies of the website of the institution with the hyperlink of the same as per provisions of clause 7(14) of the NCTF Regulations, 2014

f. The institution shall convert the above Endowment Fund & Reserve Fund into a Joint Account and furnish the evidence documents in this regard to NRC alongwith Form A showing the details of the FDR Account No. Name of the Bank and address, Phone No. of the Bank, Branch Code, IFSC Code, Signature ID Code of the issuing authority of the FDR.

Note: As per decision taken by the NRC in its 231st meeting, there shall be an Endowment Fund of Rs. 5.00 takhs per programme and a Reserve Fund of Rs. 7.00 takhs per programme. The institution is required to submit FDRs in joint account accordingly.

- 6. As per provisions of the NCTE Regulations, 2014 and decision taken by the NRC, NCTE in all related matters in its 241" meeting, the institution shall also be required to submit the following:
 - A proof/evidence to the effect that it is a composite institution as pr provisions of the NCTE Regulations, 2014.
 - (ii) In case the institutions which are not composite at present shall ensue that they have become composite institutions before commencement of the academic session 2017-18. An affidavit to this effect is required to be submitted by the institution to the NRC, NCTE...
 - (iii) No Objection Certificate issued by the concerned affiliating body as required under clause 5(3) of the NCTE Regulations, 2014.
 - (iv) It shall be noted by the institution that apart from the above, if any additional infrastructure/instructional facility is required as per provisions of the NCTE Regulations, 2014, the same shall be complied and reported by the concerned institution to the Regional Committee.

The above documents should be accompanied with written representation alongwith an Affidavit (on Rs.100/stamp paper) stating under oath for correctness of documents being submitted by the institution to NRC, NCTE.

- You are advised to comply to the above requirements before the case for formal recognition is considered under clause 7(16) of the NCTE Regulations, 2014.
- Admissions shall not be made until formal recognition under clause 7 (16) of the NCTE Regulations, 2014 is issued by the Northern Regional Committee, NCTE and affiliation is obtained from the University/examining body concerned.
- 9. The compliance report/reply alongwith all necessary documents accompanied with an Affidavit in support of the reply on the above points should be submitted within two months of issue of this letter, failing which appropriate action will be taken as deemed fit and proper.
- 10. The Regional Director is an authorized officer on behalf of Northern Regional Committee, NCTE. All the concerned Bank officers are requested to kindly consider and treated as authorization required for conversion of following FDRs in joint operation in the name of Management of the institution & Regional Director, NRC, NCTE, Jaipur.
